## Installation

**Note:** Make sure all devices you are connecting are powered off prior to installation.

- 1** Connect the VGA connector to the source's VGA port.
- 2** Connect the 3.5 mm plug to the source's audio jack.
- 3** Connect the built-in USB connector to a USB port on a USB charger or VGA source.
- 4** Connect the HDMI connector to an HDMI display.
