## Installation

1. Connect the USB-C plug to the USB-C port on your laptop, tablet or other device. The LED will illuminate blue to indicate the product is plugged in correctly.
2. Connect up to 2 USB devices to the USB-A hub ports.
3. Connect up to 2 USB devices to the USB-C hub ports.
