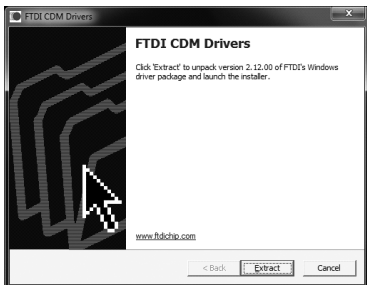
System Requirements

- Computer with an available USB-C port
- Compatible with Windows®, Mac® and Linux operating systems
- A Cisco device with an RJ45 port, such as a switch, router or firewall

Installation

Note: The following instructions show how to install the driver. Actual screenshots may vary based on the operating system.

1. Without connecting the U209-006-RJ45XC, power on your computer. Drivers for the cable can be downloaded from triplite.com/support.
2. When the driver installer program launches, follow the prompts to install the driver.

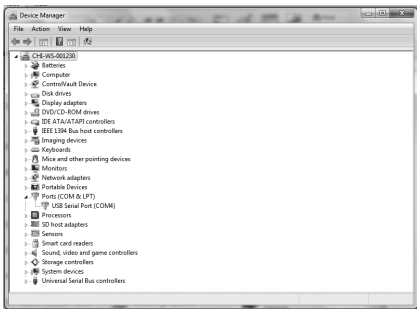
- Once the installation process is complete, click the *Finish* button to close out of the program.



- Connect the U209-006-RJ45XC to an available USB port on your computer. Windows will detect the adapter and assign it a COM port upon completing the installation.

Installation

- To verify that your adapter has been successfully installed, navigate to your computer's Control Panel and open the Device Manager screen. The adapter will appear in the Ports section with its assigned COM port next to it.
